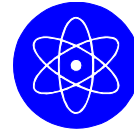

DO WE MAKE A DIFFERENCE?

The Holland Foundation (a registered & accredited tax deductible charity as per Australian Tax Office and Consumer Affairs Vic. regulations) is involved with a broad array of charitable and community building programs and projects.

We are all volunteers. There are no paid staff at all. We all provide a bit of our time, our expertise and some resources to make a positive difference in our local communities. You won't see any ads on telly about us, no posters or vans with logos.

Even if we had that sort of money we wouldn't spend it on that.

Some of our projects include;

- **ISOLATED ELDERLY LINK PROJECT** - Linking local pre-schools, kinder & school children to visit isolated elderly in local nursing homes.
- **DISADVANTAGED STUDENT SUPPORT** – Student achievement awards with financial support, computer & equipment donations to students, schools & welfare organizations, donations of books and other educational resources.
- **SCHOOL SCHOLARSHIPS** – Assisting disadvantaged students reach their goals through incentive based support.
- **SPORTS ACCESS PROGRAM** – Assisting disadvantaged children & families to gain access to sports events, to participate in sports programs eg. Junior sports courage awards, sports ticket program, equipment donation etc.
- **ABUSED & "AT-RISK" CHILDREN** – Leaving state care support, child protection access rooms project, toy/clothing/equipment donation, access to professional therapists free of charge.
- **EQUIPMENT DONATION PROGRAM** – Art equipment to therapy groups, books to child care centres, desks to disadvantaged schools, cots to young mums groups, children's videos/dvd's to waiting areas in govt. depts., soccer balls to refugee groups, baby supplies to maternal/child health centres.

- **CHILDREN LEAVING STATE CARE** – Support to young people leaving state care, financial and material aid, counselling and mentor support.
- **REFUGEE & MIGRANT SUPPORT** - Targeted student awards, donation of equipment, targeted recipients of free access to entertainment/sports project.
- **MISSING RELATIVE/FRIEND TRACING SERVICE** – many successful re-unions with lost loved ones.
- **PUBLIC HEALTH** – Financial & material aid to families with serious illness issues eg. Financial aid package (\$6000) for child liver transplant patient, advocacy on various health committees, soft toys for child surgery patients.
- **ACCESS TO ENTERTAINMENT PROJECT** – Free tickets to a myriad of events for disadvantaged families eg. Circus, magic shows, theatre etc.
- **HOMELESSNESS & FOSTERCARE** – Foundation members involved with Centre for Excellence in Child & Family Welfare, Home sharers – Foster care, Foster care Association of Victoria, Australian Institute of Family Studies.
- **TRAINING, EDUCATION & RESEARCH** – Foundation members are registered with National Child Protection Clearing House, National Assoc. for the Prevention of Child Abuse & Neglect, Aust. Inst. of Family Studies, Aust. Psych. Society, Aust. Ass. of Social Workers, Vic. Ass. of Family Therapists.
